HELLO TO MY NEW HURRICANE FAMILY!

It's been a whirlwind of excitement and energy as the school year started! I'm so glad to be here, but I'd like to introduce myself to our wider community. My name is Fr. Warren and I'm the new spiritual director of Marian Central. I'm originally from Rockford, IL where my parents still reside. I attended Boylan Central Catholic High School and Loras College in Dubuque, Iowa. It was at Loras I met many Marian Central alumni who became good friends...and it didn't hurt that the president of the college is a Hurricane, too! God's plans are funny that way.

As a focal point for the year, I leaned on the influence of a young Italian man who was raised by an influential family. His name, Pier Giorgio Fratssati. His life was quite ordinary: friendship, sports, and hard work to keep up with schooling. He had hobbies including swimming, sailing, skiing, hiking, mountain-climbing, biking, fencing, ice-skating, horseback riding. His studies included agriculture and engineering. He took piano and dance lessons and loved to sing. He could recite poetry and long passages of Dante. He translated books from Latin to Italian. He was a meticulous collector. He spoke several languages. He loved the opera, theater, and art museums. He traveled extensively and enjoyed photography. He could be the life of the party or deafeningly reverent. He was at home with the homeless on the streets as well as members of the highest classes in the embassy ballroom.

During one of his mountain climbing excursions with friends, one took a photo of him. He later scribbled "verso l'alto" on it, which translates "to the heights". This phrase has since come to encapsulate his philosophy of mountaineering and his Catholic outlook on life and adventure. He died at just 24 years old, but the massive turnout at his funeral indicated the impact he had on people of all different backgrounds. He isn't a saint yet, but well on his way.

Last year was hard, certainly for schools. This year looks to be a year of opportunity. We want Marian to go "To the Heights, Together!" which means that we want each individual in the school to be uniquely excellent. Can going up a mountain be tough? Sure, but it is achievable with a good team and it's worth striving for! If someone has climbed before us, we should reach out to be helped up. And if we get to the summit before someone else, we should turn to help them up. I'm so glad we are back in school together now. I want that togetherness to grow so we can have great trust in one another no matter what mountain we face.

My desire for our alumni community is to reflect what Pier Giorgio and my friends from Marian emulate so well...a deep love for others that flows from a life centered on Christ. There is nothing so organic, so authentic, so true as a person who lives the call to holiness that all have received at baptism. In a world that recognizes how important being "true to oneself" is, the Church would point to the dynamic lives of women and men throughout history who lived in a unique way...but focused on one goal. As alumni you are in a unique role in the team, living the mission out in the world. I invite you to pray with, and for our students. Since you have reached some summits already in your life, help our students to know they can do the same!

I look forward to going to the heights together with all of you as my mountaineering team. Please pray for me to be a good spiritual director and please pray for our Marian community this year as we go "To the Heights, Together!" Go Hurricanes!



FUND RAISING PROCEEDS

During the 2020-21 school year, the Advancement Office was responsible for administering and overseeing three fund raising efforts: Annual Fund Appeal, Athletic Benefit Golf Outing, and Dinner Auction.

These fundraising efforts generated the following net proceeds during the 2020-21 fiscal year:

The restricted gifts are deposited in accounts in accord with the donors' wishes at the time of the donation. The net proceeds from the golf outing are recorded as Development Revenue in 2020-21 operations and expended on Athletic Department equipment and supplies. Memorial donations are either restricted for a particular purpose or deposited in the school's endowment fund. The total value of the school's endowment funds invested in the Diocesan Foundation as of June 30, 2021 amounted to \$2,824,292.
